JOB TITLE:	Assistant Girls Tennis Coach

LOCATION:	Plymouth Community High School
REPORTS TO:	Athletic Director and/or Girls Varsity Tennis Coach
LENGTH OF WORK:	Pre-season, season, and post-season of the activity during the year.

ESSENTIAL FUNCTIONS include the following. Other duties may be assigned.

- I. General Responsibilities:**
- A. To provide leadership, supervision and set examples to the girls' tennis program.
 - B. Stay knowledgeable on NLC, IHSAA and USTA rules and regulations.
 - C. Attend clinics whenever possible to learn new ideas and to stay informed.
 - D. Assist head coach with the inventory and maintenance of equipment.
- II. Pre-Season**
- A. Help head coach with the following:
 1. Register all interested athletes.
 2. Hold a pre-season meeting.
 3. Make sure every athlete has a physical, code of conduct and emergency medical form on file.
- III. Season – Junior Varsity**
- A. Arrange all practices.
 - B. Help issue all equipment and keep records of each individual's equipment responsibilities.
 - C. Apply discipline in a firm, fair and positive manner.
 - D. Be responsible for every practice and every match.
 - E. Help responsible for equipment at every home match.
 - F. See that facility regulations are understood.
 - G. Make sure players conduct themselves in a proper manner on and off the court. Make sure our players treat their opponents with respect.
 - H. Establish goals with the team and individual players.
 - I. Be the last one to leave the locker room and make sure all doors are locked.
 - J. Keep the head coach informed of any problems.
- IV. Post Season**
- A. Help head coach collect all equipment and uniforms and store them away.
 - B. Help with awards banquet.
 - C. Evaluate season and suggest any changes.

QUALIFICATION REQUIREMENTS:

To perform this job successfully, an individual must be able to perform each essential function satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. EDUCATION and/or EXPERIENCE:

Certified teacher and employment with the Plymouth Community School Corporation if required by the IHSAA; or related experience and/or training.

CERTIFICATES, LICENSES, REGISTRATIONS:

Valid state driver's license - operator permit

LANGUAGE SKILLS:

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to speak effectively before groups of athletes, school officials, parents, and the press.

MATHEMATICAL SKILL:

Ability to work with mathematical concepts. Ability to apply concepts such as fractions, percentages, ratios, and proportions to practical situations.

REASONING ABILITY:

Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

PHYSICAL DEMANDS:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.
